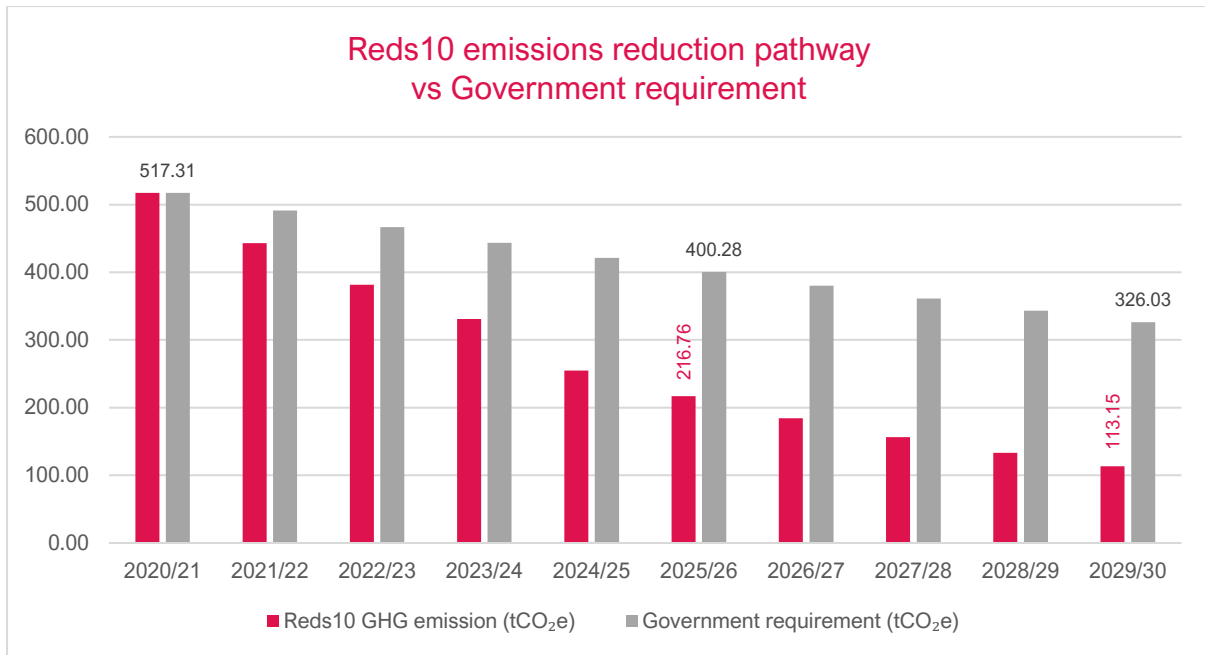

We project that our carbon emissions will decrease over the next five years to **216.76 tCO₂e** by **2026**. This is a reduction of **58%**.
